*Why don't you send it to the DVLA and tell them as the LEGAL OWNERS they have to pay this PCN. Or even write to the issuer and explain who the LEGAL OWNER is and explain they have sent it to the wrong place".*

Anything you have REGISTERED does not belong to you anymore, so when they want to PENALISE the OWNER, and send you an OFFER to pay them (a NOTICE) simply send it on to the OWNER (in this case DVLA), as you are simply the REGISTERED KEEPER. Don't believe me? Then take a look at your V5 DOCUMENT!
