Relying upon the U.S. Constitution, I can expect government to seek to:

- 1. be just. (Preamble)
- 2. insure tranquility. (Preamble)
- 3. provide for our defense. (Preamble)
- 4. promote general welfare. (Preamble)
- 5. secure individual liberty. (Preamble)
- 6. share power in balance between the Executive, Legislative and Judicial branches, with no other governmental entity possessing power except as delegated by law and with delegation subject to the limits of power specified. (Articles I, II, and III in general)
- 7. subject all agencies of government to accountability of oversight by Grand Juries operating as instruments of "We the People." (Principle of accountability)
- 8. limit the power to lay and collect taxes, duties, imposts and excises, to pay the debts and provide for the common defense and general welfare of the United States to acts of Congress. (Article I, Section 8, Paragraph one)
- 9. apply law with uniform fairness (Article 1 in general)
- 10. assure that the Writ of Habeas Corpus shall not be suspended, unless when in cases of rebellion or invasion the public safety may require it. (Article 1, Section 9, Paragraph 2)
- 11. pass no Bill of Attainder or ex post facto law, meaning that no administrative penalty shall apply to me unless the case is first heard by a jury of my peers. {Article 1, Section 9, Paragraph 3)
- 12. lay no tax or duty on articles exported from any state, preferring no state above another. (Article 1, Section 9, Paragraph 6)
- 13. spend no money but by appropriation made by law (Article 1, Section 9, Paragraph 7)
- 14. grant no title of nobility and allow no one, without the consent of Congress, to accept any present or benefit from any foreign State. (Article 1, Section 9, Paragraph 8)
- 15. provide for the honest and truthful election of all public officers. (Article II)
- 16. limit the judiciary of the Federal Government to the guarantee of a jury trial for all who are accused of a crime, except in the case of impeachment. (Article III, Section 2, Paragraph 3)
- 17. promptly bring impeachment action against all public officials and servants violating their oaths tolimit their behavior to the provisions of the constitution. (Article I, Section 3, Paragraph 6)
- 18. change provisions of the constitution only by the procedures of Amendment set out in the constitution, and not by any diversion or interpretation whether judicial or otherwise. (Article V)
- 19. exercise integrity, rejecting all proposed Amendments not conforming to provisions for Amendmentin said constitution, and that any Amendment not factually ratified is void and of no effect, including the Sixteenth Amendment documentarily proven to have been "ratified" by fraud. (Common sense and the mandate of correct ethical standards).
- 20. make no law respecting an establishment or exercise of religion. (Amentment 1)
- 21. make no law abridging the freedom of speech. (Amendment 1)
- 22. make no law abridging the freedom of the press. (Amendment 1)
- 23. make no law abridging the right of the people peaceably to assemble. (Amendment 1)
- 24. make no law abridging the right of the people to petition the Government for redress of grievances (Amendment 1)
- 25. never infringe the right of the people to keep and bear arms. (Amendment 2)
- 26. never allow a soldier, in time of peace, to be quartered in any house without the consent of the owner, nor in time of war but in a manner to be prescribed by law. (Amendment 3)
- 27. respect my right to be secure in my person, house, papers, and effects against unreasonable searches and seizures. (Amendment 4)
- 28. never issue a warrant but upon probable cause supported by oath or affirmation, and particularly describing the place to be searched and the persons or things to be seized. (Amendment 4)
- 29. never cause me to be compelled in any criminal case to be a witness against myself (Amendment 5)

- 30. never cause me to be held to answer for a capital, or otherwise infamous crime unless on a presentment or indictment of a Grand Jury except in cases arising in the land or naval forces, or in the militia, when in actual service in time of war or public danger. (Amendment 5)
- 31. never for the same offense to put me twice in jeopardy of life or limb. (Amendment 5)
- 32. never deprive me of life, liberty or property without due process of law. (Amendment 5)
- 33. never take my property for public use without just compensation. (Amendment 5)
- 34. give me a prompt trial where I am confronted by the nature and cause of the accusation. (Amendment6)
- 35. guarantee in a criminal case I shall be informed by formal certification of the cause of the accusation. (Amendment 6)
- 36. grant me compulsory process to bring to court any witness in my favor. (Amendment 6)
- 37. guarantee in any criminal case I shall enjoy the right to a speedy and public trial. (Amendment 6)
- 38. guarantee in a criminal case that case shall be tried by an impartial jury of the state and district where the crime shall have been committed which district shall have been previously ascertained by law. (Amendment 6)
- 39. guarantee in a criminal case I shall be confronted with the witnesses against me. (Amendment 6)
- 40. guarantee in a criminal case I shall have compulsory process for obtaining witnesses in my favor, and that this provision shall not be mocked by a judge who refuses to all those witnesses to appear in my defense. (Amendment 6).
- 41. guarantee in a criminal case I shall have the assistance of counsel for my defense. (Amendment 6)
- 42. guarantee in a suit at common law where the value in controversy shall exceed twenty dollars I shall have the right of trial by jury. (Amendment 7)
- 43. guarantee in a suit at common law no fact tried by a jury shall be otherwise re-examined in any court.(Amendment 7)
- 44. guarantee in any court action involving me excessive bail shall not be required nor excessive fines imposed nor cruel and unusual punishments inflicted. (Amendment 8)
- 45. guarantee if any ambiguity arises regarding the limitations of government or having to do with my rights, all such uncertainties shall not be construed to deny or disparage rights retained by the people.(Amendment 9)
- 46. guarantee that the powers not delegated to the United States by the constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people. (Amendment 10)
- 46. guarantee that no entity, private or governmental, shall ever bind me in involuntary servitude. (Amendment 14)

By citing the above (without excluding other important guarantees cited in said Constitution) the undersigned offers in a spirit of honor and good will [insert here the name of any adversary] the opportunity to refute, to instruct, to amend or otherwise to contest my understanding of my protections under the US Constitution, or to explain why said constitution cannot be relied upon by the undesigned. Your failure to respond by [30 day limit], confessing your disabilities under the limiting authority of this document, will be considered assent, and you will be expected thereafter to conform your relationship to the undersigned in accord with your oath to uphold and defend said constitution and to limit the power of your office to the provisions of that document. Any behavior on your part in violation of the provisions of the US Constitution will thereafter be actionable perjury of oath.
