EXPRESS NOTICE OF RESCISSION, SEVERENCE, WAIVER, FORFEITURE,  
TERMINATION AND REJECTION OF ADMIRALTY BENEFITS AND LIMITED LIABILITY  
PRIVILEGES DERIVED FROM A SOCIAL SECURITY NUMBER

*Statement of Non-Covered, Non-Commercial Worker Status*

Dear: \_\_\_\_\_

I am a non-covered, non-commercial, non federal, private sector worker who was coerced to sign an IRS Form W-4 as a condition of being hired or maintaining my position with the company. I am a stranger to the Public Trust. My Status falls outside the boundary lines of UNITED STATES Commerce. Therefore, I have an inherent Right to Work interest in the 14<sup>th</sup> Amendment as well.

Social Security is a wealth transfer instrument. I terminate acceptance and receipt of all benefits that otherwise inure to Social Security beneficiaries. My objections are status oriented since they define my non-involvement with UNITED STATES trade, commerce, business and industry. There is no Contract Law factual setting in effect between the company for whom I work, myself, and the UNITED STATES.

I hereby effectuate a termination, waiver, severance and rejection of my facial attachment of Equity Jurisdiction via:

1. Their Social Security Number assigned to me that you have on file; and
2. An applied Equity severance by objecting to the UNITED STATES' intervention into my relationship with the company of my livelihood; and
3. I did not enter into that closed, private domain of the UNITED STATES' commerce as a matter of choice; and
4. I also waive, reject, sever, rescind and forfeit the UNITED STATES' benefits:

- a. Not just the future benefits of retirement income, but
- b. The immediate environmental protection benefits that all Workers experience.

This EXPRESS NOTICE places all Judges and Administrative Officers, both State and Federal, on:

1. I am not a knowing, voluntary participant in the UNITED STATES Commerce or any state Commerce, pursuing that type of governmental assisted enrichment that you otherwise incorrectly assume through my silence; and
2. I am not one of those types on which the UNITED STATES or this state has reasonable expectation of taxation reciprocity; and
3. I am not one to have accepted juristic benefits that carried along with them latent reciprocal hooks of taxation expectations retained by the benefit donor; and
4. I object to one or more of the following:
  - a. That I have been threatened with termination for refusing to obtain or disclose an SSN; and
  - b. That I have been threatened to not be hired for refusing to obtain or disclose an SSN; and
  - c. The corporate UNITED STATES' forced third party relationship to the work arrangement; and
  - d. The corporate States' forced third party relationship to the work arrangement; and
    - i. The corporate UNITED STATES' intervention against my will; and
    - ii. The corporate State's intervention against my will; and
5. The corporate UNITED STATES forcing me to accept its benefits that I now hereby waive, sever, refuse, forfeit, and forego.
6. The corporate State forcing me to accept its benefits that I now hereby waive, sever, refuse, forfeit, and forego.

I claim that such unwanted and forced relationship with the corporate UNITED STATES:

1. Violates relational Principles of Nature not permissible, absent the existence of some other invisible contract of which I may not be aware; and
2. Interferes with my Right to Work under the 5<sup>th</sup> Amendment; and
3. Interferes with my Right to Work interest in the 14<sup>th</sup> Amendment as well; and
4. I explicitly reject and disavow all such commercial benefits normally deemed to be in effect through silence.
5. I agree that having grievances settled at the lowest possible level is a correct Principle of Law.
6. I require that Principles of Collateral Estoppel are now binding and mandatory on all parties involved.

***EXPRESS SPECIFIC RESERVATION OF RIGHTS:***

***I explicitly reserve all my Natural rights as an American under contract Law of the Divine Creator without prejudice and, without recourse to me. I do not consent to compelled performance under any contract that I did not enter knowingly, voluntarily and intentionally. I do not accept the liability of the benefits or privileges of any unrevealed contract or commercial agreement.***
