

The Power of Honest Curiosity:

A number of questions and concerns have been shared regarding results. Perhaps some of you have heard the expression, "faith without works is dead". Well, in relation to what one party referred to as our "process", that party recently suggested that "faith without (paper)works is dead". Its an interesting and catchy phrase, but it is not as accurate as the reality that, "faith without knowledge is also dead". In other words, if you are not prepared to do the work to learn a very, very few simple things, then your process and your paperwork, no matter how well written, is dead.

We repeatedly suggest that the paperwork is not the silver bullet, nor is it the magic wand. It is merely a written expression of one aspect of what you must know in order for the process to be successful. What do you need to know? Actually, almost nothing! Remember how to be the little child - the one that was referred as "the terrible 2's"? That child always asked questions. Questions about everything that it saw, heard and did, until it literally tired everyone around it. Was that child "smart"? Did that child need much great knowledge to ask questions? No it did not. It simply needed an honest curiosity, uncluttered by ego and false bravado!

Question: "When should I stop making my mortgage payments?" Correct Answer: "Not until you establish that your credit grantor (*bank that pretends to be a nominal lender*) is in default, and then, not until you have notified them that you have accepted their admission of being in default." Incorrect Answer: "At anytime prior to establishing their default and notifying them that you have accepted their admission of such." The reason why this is so, is because if you stop your payments prematurely, then you are *de facto* in default of your alleged contract with your credit grantor. On the other hand, if you have notified them that you have accepted their admission of being in default, you have accomplished much. First, they cannot "un-admit" what has been admitted. Second, they cannot "un-accept" what has been accepted. Third, they can only offer to deny that they are in default and to evade their own contractual obligations, they will falsely accuse you of attempting to avoid your obligations. Just like a child. "I'm not wrong - you are!"

HONEST CURIOSITY !! How hard is it to be honest and to be curious? Not very, even a little child can do it. Therefore, even we adults can learn to be as a little child, and to ask questions. We do not even require any advance knowledge of the topic. All we have to do is wait for anyone to speak, like a judge for example. Then respond to his statement or to his question, with your honest question. Think about this. It is IMPOSSIBLE to lie in the form

of a question. Therefore if all you do is ask questions, you are being honest, truthful and only expressing a genuine curiosity.

***I need you name for the record. "Why, is that because you do not know who I am, or is it because you wish to trick me into your jurisdiction?"

***I'm ordering you to sit down. "Why, is that because if I obey your order, you have tricked me into your jurisdiction?"

*** I am the judge in this court and I have jurisdiction. "Why, do your laws supersede the natural laws of My Creator?"

*** If I am not a third party representative for my Estate, how does this man next to me claim to be a third party representative for someone that pretends to have a claim against me, yet even he does not know who I am?

*** If you are the judge, why do you ask me questions? And if you ask me questions, who will judge my answers? Are you not supposed to be impartial? I thought the man next to me would ask questions and you would judge my answers?

*** Am I presumed innocent until guilt is proven?

***Am I presumed innocent of all aspects of the charge?

***Is proper jurisdiction and authority an aspect of the charge?

***Before we start, will you please explain to me how you obtain jurisdiction over me?

If the above brief examples are not something you are curious about, I hope your reason is simply because you have no pending legal matters. If you do have pending legal matters, then you should honestly be curious about these and other issues. If you are honestly curious, then you not only have the right, but you have the duty and the obligation to ask the questions. If you do not ask, they will not tell you. If you tell them, they will compel you to prove it, therefore, you must ask. It is your duty because it is always your duty to do what is right, true and honest. It is your obligation, because you have been given these truths freely from your father, who is the only owner of all truth, therefore if you do not truthfully question your accuser, you are dishonoring your Father by not accepting His first and His best gift, that of having given you dominion over all of the planet and the free will to choose truth. It is your decision, not mine or His.
