

Notice of Understanding and Claim of Right

I, Simon: of the Elder family, a Freeman-on-the-Land, a flesh and blood living human being in possession of a sovereign and individual spirit, a living soul, do hereby make Oath and state that the following is My Truth and My Law, in addition to those extant in my Notice of Understanding and Intent and Claim of Right which was perfected on 2nd April, 2009:-

Whereas it is my understanding that any right that you, the DVLA, may claim over my private conveyance, known to you by the vehicle registration number V*****, has been acquired by deceptive means designed to elicit my consent, and

Whereas a Freeman-on-the-Land has lawfully revoked consent and does exist free of statutory restrictions, obligations, and limitations, and,

Whereas it is my understanding that any action, for which one can apply for and receive a licence, must itself be a fundamentally lawful action, and,

Whereas I am not a child and I am a Freeman-on-the-Land who operates with full responsibility and I do not see the need to ask permission to engage in lawful and peaceful activities, especially from those who claim limited liability, and

Whereas it is my understanding that I have a right to use all property in my possession without having to pay for the use or enjoyment of it, as all contracts between legal fictions are null and void because such contracts were created deceitfully and without my full knowledge and consent, and,

Whereas it is my understanding that my purchase of my car, my possession of it, my upkeep and maintenance of it, proves that I am the lawful owner and have sole claim to it, and,

Whereas it is my understanding that any statute that you use to back any claim you may make to control whatever form of private conveyance as I may choose to operate on roads and highways is only applicable if I choose to consent, and,

Whereas it is my understanding that as a Freeman-on-the-Land I have withdrawn my consent to be so governed, and

Whereas it is my understanding that any notices served under such statutes are unenforceable as they are subject to Acts which do not apply to a Freeman-on-the-Land, and,

I hereby serve notice and state clearly, specifically and unequivocally, that under the law and customs of England

and Wales, of which Her Majesty Queen Elizabeth II has sworn oath to protect, I make claim to what is rightfully, lawfully and justly mine.

I claim full lawful rights, allodial title and ownership of any form of private conveyance in my lawful possession and the use of it freely on roads and highways, or on private land, acting with reasonable care and responsibility to third parties and road users.

I claim it is my lawful right to travel and use any type of private conveyance on roads and highways, without let, hindrance, levy, licence or duty.

I claim that any consent, which may have been either expressed or implied by myself in regard to or in relation of any statute regulating the operation of any form of conveyance on roads and highways, is withdrawn.

I claim that any registrations with the DVLA are now void.

I claim the right to put reference plates on my private conveyance of a size, style, colour, lettering and numbering of my own choosing, in a clear fashion so that any interested relevant party can refer to the exact status of myself and my private conveyance. As a courtesy, notice will be sent to yourselves informing you of the reference for your records.

I claim the right to park my private conveyance anywhere in which it is not causing an obstruction.

I claim the right to use or accept any word or words to describe a private conveyance being owned or used by myself, or words used to describe the operation or occupants of the conveyance, including but not limited to; vehicle, motor vehicle, car, automobile, driver, driving, passenger, and that the use or acceptance of those words does not, in any way, shape or form imply any consent to come under any statute. I also claim that I have the right not to be held accountable for the use of those words by any of the guests of my conveyance.

I claim my FEE SCHEDULE in regard to my lawful rights to freely travel and park on the roads and highways of the British Isles for any transgressions by any police officers, government principals or agents, or justice system participants is £100 (ONE HUNDRED) GB POUNDS for affixing any notices or paperwork to my private conveyance, £30,000 for removal of or interference with this privately owned conveyance and £500 (FIVE HUNDRED) GB POUNDS PER HOUR or part thereof, if and from the moment of being stopped (with the exception of being stopped by a uniformed police officer who has lawful just cause), questioned, interrogated, or in any way detained, harassed, or otherwise regulated; and £1000 (ONE THOUSAND) GB POUNDS PER HOUR or part thereof, if and from the moment of being arrested, handcuffed, transported, incarcerated or subjected to any adjudication process without my express written and notarised consent. Also if violence is done to myself or people under my care and protection, or damage or loss occurs to my privately owned or hired or borrowed private conveyance, the fee shall be £20,000 (TWENTY THOUSAND) GB POUNDS in addition to any compensation that may be awarded.

I have the right to convene a proper court de jure in order to address any potentially criminal actions of any police officers, government principals or agents, or justice system participants who, having been served notice of this claim, fail to dispute or discuss, or make lawful counterclaim and then interfere by act or omission with the lawful exercise of properly claimed and established rights and freedoms.

I claim the right to deal with any counterclaims publicly and in an open forum, using discussion and negotiation for whatsoever lawful purpose as I deem fit.

Affected parties wishing to dispute the claims made herein or make their own counterclaims, must respond

appropriately within 14 (FOURTEEN) days of receipt of this notice. Responses are required to be made under oath or attestation, upon full commercial liability and penalty of perjury and received via recorded delivery mail addressed to the address at the top of this notice.

Failure to register any appropriate dispute or objection against the claims made herein will mean that you agree with my understanding and claims, and will result in an automatic default judgement and permanent and irrevocable estoppels by acquiescence barring any claims or the bringing of charges by you or any interested third parties under any statute against myself for exercising my lawful and properly established rights and freedoms.

Sincerely and without ill will, frivolity or vexation.
